After the KRBAAS Intervention to take Social Rehabilitation centre (SRC). After the admitted rehabilitation at Magadi (v) Ramanagara (D) He was regular with his Therapy and Learnt all the Activity of daily Living Skills (ADLS) without any Assistance. Try to motivate Accessibility supported on Home based and was counseled and given Mobility aids. They give him Confidence to lead an independence life.

Through the KRBAAS Advocacy he got 3% grants from the Gram Panchayath. Currently he is working has a self-employee driver with Modified Auto. The Family feedback KRBAAS support was appreciated. This has given them hoped and aspiration.
